Holiday Basketball E-Card 2024
Official Rules

1. **Eligibility. “Holiday Basketball E-Card”** (the “Promotion”) is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, (“PCH”). Employees of (“PCH”) are not eligible to participate in the Promotion.
2. **Agreement to Official Rules.** By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.
3. **Promotion Period.** The Promotion period starts at 12:00 a.m. Central Time (CT), November 20, 2024 and ends at 11:59 p.m. CT, November 27, 2024 (the “Promotion Period”). PCH’s computer is the official time-keeping device for this Promotion.
4. **How to Enter.** All guests who are Wisconsin residents and access the website on paysbig.com can participate, including those who are sent an email or who like or follow our various social media pages.

No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

5. **Free Entry.** No purchase necessary, purchase will not increase your chances of winning. Void where prohibited.
6. **Drawing and Notification:** The qualifying guests mentioned above will receive a Holiday Basketball e-card from PCH, or see a social media post with a link to play a holiday themed game online. Guests can play as many times as they want during the Promotion Period. Each time they play, the guest will attempt to aim the basketball into the hoop using the platform to earn points. The scores will be logged electronically by a third party (Trivera) and accessible to PCH to track the daily winners.

How it Works:

- The top score at the end of the day wins.
- If there is a tie resulting in more than one high score, both guests will win.
- All daily winners will receive a \$25 PCH gift card + a \$25 Bucks Pro Shop gift card each.
- When the game is complete, the guest will be instructed to enter their email address. Guest will not be entered into the contest unless they provide their email address.
- Winners will be notified via email ONLY.

- Winners will have until December 15, 2024 to claim, otherwise they forfeit their prize, with no further compensation
- Gift Cards expire November 1, 2025.
- There is no limit on the number of times the game can be played, but guests can only win once each day

7. **Prizes.** Prize includes the following (8 winners total):

- \$25 Bucks Pro Shop Gift Card

Please note: The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash.

W-9 form must be filled out for any cash/trip/prize over \$50. Winner must present a valid ID and Fire Keeper’s Club card to claim prize. A valid ID includes any government issued ID such as a driver’s license, passport or state ID card.

8. **Prize Acceptance/Restrictions.** Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The winners will be required to provide valid picture identification and a Fire Keeper’s Club card to claim prize; membership is free. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. **Release, Publicity, Use of Personal Information.** Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. **General Conditions.** In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
