Official Rules

#### 1. Eligibility.

**\$300K Cash Clash** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

#### 3. Promotion Period.

The Promotion period starts at 12:00 a.m. Central Time (CT), November 1<sup>st</sup>, 2024 and ends at 8p.m. CT, November 21<sup>st</sup>, 2024. PCH’s computer is the official time-keeping device for this Promotion.

#### 4. How to Enter.

**Promotion is valid at the Milwaukee location only.**

All guests who have a Players Club card may enter.

**Exclusions: Live Poker is excluded from earning points toward this promotion.**

- **Earn Entries:** Guests can receive entries for every 100 base points earned on their club card starting at midnight November 1<sup>st</sup> through 8pm on November 21<sup>st</sup>, 2024.
- **3x entries on drawing dates**
- **Activate Entries:** To activate entries for electronic drawings swipe Players Club card into any promotional kiosk, enter PIN and select promotions tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

***Must be present to win. No mechanically reproduced entries will be permitted.***

## 5. Free Entry.

## 6. Drawing and Notification.

- 4pm – 5pm – 6pm – 7pm – 8pm
- 10 winners each hour
  - 8 Winners receive \$625 Reward Play
  - 2 Winners play the Cash Clash game show
- **Hourly Prizes:**
- \$15,000 to be played out between 2 players, prize amounts to be determined through the game.
- Minimum \$4,000 / Maximum \$,11,000 Cash Prizes
- **Example:**  
**Starting Cash \$7,500 (Both Players 1 & 2)**  
**Ending Cash Prizes: Player 1 - \$5,000 / Player 2 - \$10,000**

### How it Works:

- Must be Present to win
- Check-in required
- Winners will have 10 minutes to come to the Promotions stage
- Redraw time frame will be cut to 5 minutes
- After checking in, winners will assemble in front of the stage and choose an envelope to determine their prize or game play status
- Entries carry over from week to week
- Guests can start activating their entries at 3pm on Thursdays; then must reactivate between each drawings

### Cash Clash: How it Works

- Behind each Tile Number are different game tile instructions:

- **ZERO** - this does not change either player's score
- **-\$\$\$\$** - subtracts that amount from the player's bank and adds it to the opponent's bank
- **EQUALIZER** - both player's banks go back to their starting banks
- **SWITCH** - player banks switch
- **END GAME NOW** - the player has the option to end the game now
- After Player 1 takes their turn, Player 2 plays. Each Player is allowed 5 turns.
- Once a numbered tile is picked, it cannot be picked again.

PCH reserves the right in its sole
