Official Rules

1. Eligibility.

Senior Day Kiosk Game is open to those fifty five (55) years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 6:00 a.m. Central Time (CT), and ends at 11:59 p.m. CT each Wednesday in July, August, and September:

- Wednesday, July 3rd, 10th, 17th, 24th, and 31st, 2024
- Wednesday, August 7th, 14th, 21st, and 28th, 2024
- Wednesday, September 4th, 11th, 18th, and 25th, 2024

PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

All Players Club members fifty-five (55) years or older may play the Senior Day Kiosk Game. After earning 55 same-day base points, guests must swipe their Players Club card into any promotional kiosk, enter their pin number, select Monthly Promotions and then touch “Senior Day”. Guests can participate up to 5 times each Wednesday. Senior Day is available from 6 a.m. to 11:59 p.m. on Wednesdays in July, August, and September. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Eligible guests that sign up for a Players Club card will be eligible to participate that same day.

Earn Entries: Players Club members fifty-five (55) years or older who earn fifty-five (55) same-day base points or more on Wednesday can swipe at the Kiosk and play the wheel spin game to receive a Reward Play offer.

Guests can spin the wheel up to 5 times each Wednesday from the points earned that day.

6. Drawing and Notification.

Must be present to win.

After earning 55 same-day base points on their club card; guests can play the Senior Day Kiosk Game and win Reward Play. Guests can now participate and spin the wheel up to 5 times each Wednesday for every 55 points earned that day. The Senior Day kiosk game will be available from 6:00 a.m. to 11:59 p.m. Guests can go to any promotional kiosk, swipe their card, put in their pin number, select Monthly Promotions and then touch “Senior Day”. Points can be earned starting at 12:00 a.m. but the game is only available from 6:00 a.m. to 11:59 p.m. The kiosk game must be played the same day as points earned. Reward Play is good for 7 days after redemption. PCH has the sole authority to determine the winners and such decisions are final.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners may be required to provide valid picture identification and Players Club card to claim prize. Prizes are not transferrable or assignable.
