**Official Rules**

**1. Eligibility.**

**W2G Score Even More** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

**2. Agreement to Official Rules.**

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

**3. Promotion Period.**

The Promotion period starts at 12:00 a.m. Central Time (CT), October 1<sup>st</sup>, 2024 and ends at 5p.m. CT, November 4<sup>th</sup>, 2024.

PCH’s computer is the official time-keeping device for this Promotion.

**4. How to Enter.**

- **Promotion is valid at the Milwaukee Location only.**
- All guests who have a Players Club card and have won a taxable jackpot in the month of October, 2024, may enter. Guest must be actively using their Players Club card when the jackpot is won. Guests will receive one entry into the drawing for each taxable jackpot from a slot machine the month preceding the Drawing. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.
- **Activate Entries:** To activate entries for electronic drawings swipe Players Club card into any promotional kiosk, enter pin number and select promotions tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

**How it Works:**

**9. Release, Publicity, Use of Personal Information.**

**10. General Conditions.**
