### Official Rules

#### 1. Eligibility.

The Poker Room's "Multiplier Madness" is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Hotel & Casino Banned Patron List. Employees of Potawatomi Hotel & Casino ("PH&C") and the immediate family members of the Marketing Department, Player Development Department and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse, or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PH&C, which are final and binding in all matters related to the promotion.

#### 3. Promotion / Qualification Period.

The qualification period for The Poker Room's "Multiplier Madness:

- Qualifying play time begins at 12am Central Time (CT),
- Qualifying ticket times starts at 12pm with first drawing at 5pm

**Ends August 30<sup>th</sup>, 2019**

- Final drawing at 10pm

**Weekly Promotion Days:** Mondays – Fridays / 12am – 10pm

### How it works / Multiplier Madness

- From 12pm – 9:59pm Players in live Texas Hold'em games, who show a full house or better, will receive a drawing card from the dealer.
- The dealer will verify the hand.
- All drawing tickets will be collected and placed into the drawing tumbler.
- Daily drawing times: 5pm – 6pm – 7pm – 8pm – 9pm – 10pm
- Guests need not be playing in a live action Texas Hold'em game at the time of the drawing
- Each drawing will be for \$100 plus any Multiplier Bonus for time played
- Multiplier Bonus to be verified by Floor Supervisor prior to payout
- Multiplier bonuses will work as follows:
  - 0:01 to 1:59 hours played, the prize is \$100
  - 2:00 to 3:59 hours played, the prize X1.5 (\$150)
  - 4:00 to 5:59 hours played, the prize is X2 (\$200)
  - 6:00 to 7:59 hours played, the prize is X2.5 (\$250)
  - 8:00 or more hours played, the prize is X3 (\$300)

***Any time played between Midnight and the current drawing time will count towards Multiplier Bonus Hours:***

***For example:*** If you played from 1am until 4am, and then again from 2pm, and were called for the 6pm drawing time. You would have a total of 7 hours played and would receive the X2.5 multiplier. (Only time at the table would count, anytime you are paused would not qualify as active time.)

- Drawing Cards will be selected until there is a winner at every drawing time
- Entry tickets are non-transferable
- Winning tickets will not be returned back into the drawing barrel
- Drawing barrel will be emptied at the end of each day and tickets will have to be re-earned

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners will be required to provide valid picture identification and a Fire Keeper's Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PH&C, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

**8. Release, Publicity, Use of Personal Information.**

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

**9. General Conditions.**

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PH&C may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PH&C reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PH&C reserves the right to seek damages from any such person to the fullest extent of the law. PH&C's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
