1. Eligibility.

Power Hours is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, (“PCH”). Employees of (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 6:00 a.m. Central Time (CT), and ends at 6:00 p.m. (CT), each Monday in October:

- Monday, October 7th, 2024
- Monday, October 14th, 2024
- Monday, October 21st, 2024
- Monday, October 28th, 2024

PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee location only. Power Hours Jackpots are available to all guests who are actively playing on an eligible slot machines during the Jackpot period. Actively playing is defined as a wager being placed at least once every 30 seconds. A Players Club card is required to participate in this promotion. Any wager played in an eligible machine could trigger a Power Hours Jackpot. Winners are chosen at random from all active slot machines, regardless of the denomination, or length of time they play.

6. Drawing and Notification.

Power Hours Jackpots are completely independent of the game outcome. No max bet or winning reel combination is necessary to win a jackpot. When a Power Hours Jackpot is triggered, the guest will play a Special Bonus Game called “**Safe Scan Bonus**”. This game is displayed on the slot machine using the same screen as the Player Account info.

- **Power Hours Jackpot Amounts: (3)**

- **\$10,000 Cash** - A fixed jackpot (slot attendant will assist)
- **\$1,000 cashable slot credit** - A fixed jackpot (automatically downloaded to machine once guest confirms jackpot)
- **\$100 cashable slot credit** – A fixed jackpot (automatically downloaded to machine once guest confirms jackpot)

Power Hours Jackpots are non-transferable.

Projected Total Value: Dependent on activity during Promotional Period.

Please note: The winners of any and all prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash. \$10,000 Power Hours Jackpot winners will have to present a valid ID and second form of identification to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport or state ID card.

7. **Prize Acceptance/Restrictions.** Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

8. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

9. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to

seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**

Entrants agree to release and hold harmless Potawatomi Bingo Casino, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them (“the Released Parties”) from and against any claim or cause of action arising out of participation in the Promotion, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Promotion or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Promotion or acceptance and use of any prize. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
